- 2. All fees and charges shall be payable in advance by the start of the Term to which they relate. The School reserves the right to remove or refuse entry to any student whose fees are not paid in accordance with this requirement.
- 3. Without prejudice to the requirements of Condition 2, a Late Payment Fee will be charged on any overdue account at rates determined from time to time by the Board of Directors.
- 4. **One full term's notice in writing** must be provided to the Headmaster at headmaster@bgs.vic.edu.au prior to the removal of a student, otherwise one fourth of the total Annual Fees will be charged.
- 5. The School has the right to determine the appropriate year level of a student's entry, and progression is dependent upon satisfactory performance in the opinion of the School.
- 6. I/We agree to fulfill the expectations of the School as outlined in the Parents' Charter. A copy of the Charter is available by contacting the Admissions Office or on the Ballarat Grammar website.
- 7. The School reserves the right to discipline, suspend or expel any student whose lack of academic endeavour or whose behaviour is considered by the Headmaster to be unacceptable.
